#### **EXECUTIVE BOARD MEETING**

# WEDNESDAY 7th September, 2016

Start time: 12.00 pm

**Apologies:** No apologies

Trevor Adamson Chairperson discussed the role of Executive and Administration partly in Pitjantjatjara and English. Smooth operation of Board, doing things better.

T. Adamson - refers to a letter from Mr Kyam Maher - Minister and discusses it and reads letter out in language.

Mr King - explains the construction of the Agenda for today's meetings and their items- Richard stated that the Agenda items, at times requires 3 months lead time in preparation. Changes the night before the meeting are disrupting the business.

Gary Lewis - from 1981-2005 executive ran the APY Lands. "We cannot have a General Manager going to Adelaide and talking to Government when we do not know what is happening. This is very dangerous and we have to stop it".

R. King - explains his role between Government and Executive and stresses that he (R. King) does not make decisions. The purpose is to provide opportunity for engagement.

Short discussion about Cattle money.

T. Adamson - refers to the letter from the Minister in regards to setting up a cattle business that benefits all Anangu. Referring to R. King- he is a good man to run administration but should not be involved in the cattle business.

Bernard Singer - stated the cattle business need to move forward and improvements are required. Role of the General manager- he has been improving day by day business for APY. We need to be looking up to him for the job he is doing (including the cattle business).

I am just going through the letter- the appointment of an Administrator will be considered if we go back to past practices. Anangu should help Anangu.

T. Adamson - I came in as Chairperson- we need to put more pressure on him (R. King)

The cattle money is there, it needs to be done 'right way'.

R. King should leave the cattle manager to work with the people, he needs to.

A discussion about Travel Allowance was raised.

R. King - explains Travel Allowance: For APY employees there are three different levels of allowances if you're on the lands, if you're in Alice Springs and in a capital city. R. King explained why and when he travels to Adelaide, what meetings and timeframes are set to continue to complete APY Business with funders/stakeholders from Adelaide.

# **Discussion around Lawyers for APY.**

- T. Adamson raises that he has identified a new Lawyer for APY.
- O. Burton that name (Lawyer) is coming from someone- we are rushing, we need to do things properly under the Land Rights Act.

M.George - somebody has put the General Manager in charge of everything, he needs to be under the Land Rights Act.

If we kick him out- (R.King), which area is the problem going to come from for the Minister to put in an Administrator.

- B. Singer -In language to T. Adamson.
- O. Burton through the chair "to make it fair we need to talk about this Lawyer, this is my opinion. We do not know this Lawyer you T. Adamson are pushing- he has not been here we do not know him we need a proper background story from this lawyer. I want to meet and see the picture which communities he has been too.
- B. Singer there is a process that must be followed in appointing a lawyer. If the process is not followed then we could wind up with an Administrator.
- R. King you cannot just bring in a different Lawyer, needs to follow proper procurement processes.

- O. Burton if we don't follow the process then there would be trouble.
- T. Adamson asking for a mover and a seconder

There was widespread discussion about voting on a change of Lawyers.

## RESOLUTION: A vote was sought on the change to APY Lawyers.

- 4 in Favour (Mr Brumby, Mr Lewis, Mr George, T. Adamson).
- 4 Against (C. Anytjipalya, A. Baker, O. Burton, B. Singer)
- 1 Abstained (W. Pompey)

#### Not Carried.

There was a discussion around an Executive Assistant to the Chairperson. There was a person that entered the meeting accompanied by T. Adamson.

- B. Singer- referring to the person that accompanied T. Adamson, whom has taken a seat at the table. "Who is this person"?
- T. Adamson he is an observer.

This person was asked to leave the meeting.

T. Adamson - "I am not going to listen to you R. King" I want a person to be an Executive Assistant to help with work, Not Rex.

- T. Adamson I want to confirm that the appointment of the nominated new Lawyers for APY. Who are the mover and seconder so I can move on?.

R.King - this has already been done it is in the minutes. You cannot keep going back to this, the resolution was not passed.

G. Lewis - the Minister does not control the Lands, he has no power you are 'blackmailing' us. That's blackmail. How can an Administrator come in and take control?.

R. King - some executive members left when the vote for new Lawyers was taken.

The members that left the room were: A. Baker, B. Singer, C. Anytjipalya and O. Burton.

# **Kumanara Paddy's family**

T. Adamson - I want to follow up on Mrs Kumanara Paddy's family want to say a few words (ex Chairperson).

Discussion regards compensation for the family of Kumanara Paddy continued, they would like Executive to do an appeal to government, cattle money, local government, mineral exploration money for compensation..

B. Singer - let us wait until there is a reply to the letter already sent appealing for funding for compensation that was sent to Craig McCauley DSD – AAR.

T. Adamson - "We are supporting the family and we want a little bit of money for compensation.

O. Burton - we have no power, we should take it to a general meeting and Executive should agree.

R. King - to Sammy Lyons only bring in the Camels when Troy is ready to pick them up. Otherwise it can cost too much to feed them.

R. Tjami - asking about numbers of camels being taken away?

T. Coe – T. Coe stated they removed approximately a 1000 camels.

G. Lewis - we have to have a written agreement.
