EXECUTIVE BOARD MEETING

Item one - Welcome

Item Two - Legal Update - Ruth Morley

Ms Morley gave the executive board an overview of the legal work that is being done-Leasing pastoral, mining, agreements with DPTI roads business, mobile towers, ongoing work with Anthropology regarding consultation and HIA's, so that everything is done in line with the APY Land Rights Act.

Permits: only executive board can issue permits. Anyone who is not Anangu needs a permit to enter the Lands and all permits come through APY Permits office. (Part 3, Section 2 Land rights Act) If people are on the APY without a permit, APY can ask them to leave and can also fine them \$2000 with \$500 fine for every day they remain on the lands without a permit. There are some exceptions such as government, police that don't need a permit. Executive had a discussion and a Memorandum regarding permits to be written and sent out to all agencies, stores, schools across the APY Lands. Executive had discussion in regards to PYKU managers

Resolution

APY Executive board resolve to send letter to Mr Miller in regards to his lack of permit, inviting him to put an application for permit in.

Ms Morley spoke about Cave Hill and the National museum. The National museum has invited an Anangu person to talk with them next week who is not a Traditional Owner (TO) for Cave Hill. Executive had a discussion in regards to this.

Resolution

Executive board give permission for Mr Brady to be used as an interpreter, but must use Traditional Owner, at their own expense to cover expenses of interpreting and travel.

Ms Morley explained the court cases that were happening at the moment and the involvement of people. Executive had discussion in regards to court cases and also the people involved.

Resolution

APY Executive board resolves to appoint Michael Roder QC to appear in the Supreme Court proceedings APY v DSD&ORs No 1198 of 2017 in the hearing on 25/1/2018.

Discussion occurred in regard to a number of Non Aboriginal people on the lands `whom are involving themselves in APY Executive Board Business. This activity is undermining the board's statutory responsibility and must be addressed.

Item five - NBN Satellite - Justin Forsell and Tim Saul

Mr Forsell and Mr Saul presented a presentation in regards to NBN satellite internet and how it works. Installation of satellite dish is free, the internet sourced by user from providers. The team will be commencing a roll out across the lands soon.

Item six - Oz Minerals - Geoff Deans

Mr Deans did a presentation in regards to Application ELA881. Executive looked at map, same area as electromagnetic survey for water. Executive had a discussion in regards to application and are waiting for water survey to come back before they can decide whether to progress the application

Item four – Changes to Constitution AGM resolution to be accepted and Letter sent to Minister advising

Mr King showed executive a letter that has been drafted to the Minister advising him of changes to constitution that were agreed to at AGM. A short discussion occurred.

APY Executive Board give permission for letter to Minister Maher regarding changes to constitution to be sent to the Minister for Aboriginal Affairs.

Item 3 - Anthropology - Charmaine Jones

Three updates were presented to the Executive board. Pastoral meeting held 27/11/17 to talk in regards to future pastoral camp. Meeting to be held next year around the David Well Pastoral project.

SA Water search survey Amata progressing – A variance was discussed in regard to fill material for football oval. Executive had discussion

Executive board give principal support to Anthropology HIA report for Site 1, map of Amata survey area as presented by APY Anthropology on 7/12/17.

Executive board give approval under Section 9F of Land Rights Act to Mr Richard King and in consultation with Rex Tjami, to make decisions on any site differences to the above HIA report regarding Amata soil site with APY Anthropology

Toll Camp for Stage 2 road construction was discussed. There were some issues in regards to what people were consulted for the HIA and if they were the correct TO's to consult with.

APY Executive direct APY Anthropology to re consult with the TO's again and present HIA for Stage 2 camp construction with APY. Director Rex Tjami and correct Traditional Owners must be present.

Discussion occurred in regard to the process for ensuring the right TO's attend the consultation for clearances. There was some concern in regard to the TOLL camp clearance.

Executive give direction to APY Anthropology to do a flow chart for surveys, one for HIA's and one for identifying and working with Traditional Owners and to bring back to APY executive board at February 2018 meeting

Item seven – Ayers Rock Voyages Resort – Kerry Anne Liddle

Ms Liddle works with ILC and wants to talk about how Ayers Rock Voyages consult with Anangu. Executive discussed – talk to TAFE, keep executive informed. TAFE and PYEC already involved with Ayers Rock resort and students. Executive would like a plan presented on how to better engage with current stakeholders.

Item eight - CASO Co-ordinator Update

Introductions of the new CASO Coordinator were done. Bonni talked about working remote last ten years and now working for RASAC as CASO Coordinator. The job includes helping CASO's across the APY Lands, Working with community councils is 2nd part of the role. The new Coordinator would like to work with APY Executive members and ask one representative to attend their community council meeting, so that better communication can happen between councils and executive. Executive had a discussion and will ensure councils become a standing agenda item from 2018.

Item ten – other business

DECD – Reuben Burton

Presented quote from Furnell's to fix up power to youth shed in Kanpi. APY will pay 50%, DECD will pay 50%. HIA will need to be done in regards to trench digging.

Complaint that Anthropology have said it will be March 2018 before HIA will be done in Mimili in regards to cable digging. Mr King explained that Anthropology have a full work load and are prioritising

Consultation regarding shed in Pukatja to be done by APY Anthropology. DECD to contact APY Anthropology in regards to this.
