1. Welcome

The meeting commenced at 10:10 am with a prayer by Kawaki Thompson.

Gary Lewis requested to have AP Services permits issues on the Agenda. Chairman noted it could be covered in Permit Issues already on the Agenda.

Gary Lewis presented the written *appointment of proxy* from Murray George to Gary Lewis (until it is revoked in writing).

2. Executive Board Status of Gary Lewis, Murray George, Leonard Burton.

The presence of Mr Lewis and Mr Burton was discussed at length and the members argued the continuation of the meeting. Mr Huntington explained that Minister Weatherill wanted the meeting to go ahead and the Court had restrained APY from proceeding with the meeting unless APY allows the three men to attend and participate as members in this Executive Meeting only and that there is a quorum not counting the three men. The Conciliation is to occur on 23/24 October 2008.

Mr Singer explained that at the recent General Meeting that these three men directed very strong language against the other Executive Board members. In view of his personal feelings and understanding that the meeting should continue as it had important matters to consider, he stepped down from the Chair and requested the Deputy, Mr Sean Williamson take the Chair. Mr Singer left the meeting shortly thereafter.

3. Housing Leases

Mr Lewis requested that the MOU with housing be negotiated directly between State government and the Communities. He also argued over the definition of Traditional Owner as it had been used in consultations and requested further explanation of the contents of the Leases. Mr Huntington explained that the meeting is about the Amata leases and the variation to the leases and not the MOU.

The Map of Amata was passed around to identify the 11 sites to be leased to the State for 50 yrs as per the resolution of the special general meeting. Mr Lewis argued that it needs more consultation. Mr Reardon explained his discussion with Mr Burton that Mr Burton wants the houses and supports the leases and agrees that the consultation has taken place.

Mr Burton said he was leaving the meeting because he was not a part of the group. He said he is allowed to come to the meeting but the meeting should be closed till conciliation. Mr Huntington and Mr Tjami requested that Mr Burton stay. Both Mr Burton and Mr Lewis left the meeting at approximately 11:30. Mr Kenny also left the meeting, without giving reason.

Mr Huntington contacted Finlaysons to advise the legal representatives of Mssrs Lewis and Burton that they must return to the meeting by 12:00 noon or the meeting would continue.

Mr Singer returned to the meeting.

At 12:00 noon

Present: Campbell, Anytjipalya, Singer, Thompson, Baker, Williamson, Tjami, Huntington, Edwards. Mr Williamson remained in the Chair.

Mr Huntington explained the Ground Lease for the 11 houses at Amata and the variations that had been made, and the comfort letter that had been received.

At 12:05 Lewis and Burton returned. Mr Max Kenny did not return.

Mr Huntington continued and read out the comfort letter. The MOU is to be developed later. A copy of the letter was provided to Mr Lewis. The Minister manages public housing and will not contract out the important features of the public housing. General discussion.

Resolution

That APY sign the Ground Lease for housing for 50 year leases to the Minister for Housing over the 11 sites at Amata and the Variation of that lease negotiated by APY Administration since 22 Aug 2008.

Mr Huntington described a lease that was almost exactly the same terms as the Ground Lease including for 50 years, for new police stations and facilities at Amata, Mimili and Pukatja.

Mr Lewis wants more consultation and negotiation in Pukatja and raised the issue of the definition of Traditional Owners. Mr Huntington explained there has been considerable consultation in Pukatja including meetings with Traditional Owners. Mr Singer explained that everyone knows about the police stations and we should remove Pukatja from the lease if there is going to be a problem signing the lease.

Resolution That APY signs the leases for 50 years to the Minister of Police for the police stations and infrastructure at Amata and Mimili.

ACTION: Write to the Minister to explain the resolution to remove Pukatja from the 50yr lease for the police stations.

Mr Huntington explained about the long term leases for two duplexes for DFC at Umuwa.

Mr Huntington explained that forms for leases have been received for lots in Umuwa for short term accommodation for SAPOL and DFC staff and for long term accommodation for Child Protection workers.

That APY signs the leases for 2 years over Lot UMU415 and UMU417 for short term accommodation for DFC and SAPOL staff

Mr Singer resumed the Chair.

Resolution

That APY signs the leases for 50 years over Lot UMU 416A/B in Umuwa

Members signed the various leases.

2:00 pm meeting reconvenes from lunch. Mr Singer resumes the Chair.

3. Ahava Energy presentation

Djonny Suwanto provided the information booklet and powerpoint presentation about the company, its objectives, the petroleum exploration activities in the Officer Basin and talked of the mutual potential benefits. Mr Singer explained that the exploration area has many 'no-go' areas and they need to be defined through work with PIRSA. Mr Cockshell said it is a 2-part process in defining these areas. Ahava Energy will be conducting seismic work for approx 4 months in the Marla area from Jan 09. There is seismic work being conducted by GeoScience (Federal govt Department) that is to follow the railway reserve starting in late Oct- Nov.

Action: Gary McWilliams to contact Ahava re future site inspection and familiarisation visit and GeoScience re seismic work in the railway corridor.

4. NPY Women's Council presentation

There is a General Meeting at Tilun Tilun next week 7-9 Oct. Mr Singer requested Ms Gillick raise the issue of promoting women in the next Executive election.

(a) Ms Gillick explained of their meeting with the Mullighan Inquiry.

(b) They are running 'Speak Up Against Child Abuse' and handed out some T-Shirts. This program is working with the Pukatja community, school and some individual community members.

(c) Sheila Brookes (She) and Jim Osborne are also working in Pukatja on sexual assault. Council is looking to locate a senior staff member in Umuwa to liaise with the agencies now working in the area of sexual assault.

(d) There is a school holiday project. Council is trying to get more Youth Workers on the ground – there are only 3 on the Lands and the turn-over is high. Some kids need case management. Need male and female workers.

(e) In Coober Pedy, Council is trying to get alcohol restrictions similar to the roadhouses. Cant get take-aways is a first step. Ms Mason requested APY to provide a letter of support for the restrictions.

(f) Council provided submission to Senate Committee Inquiry into Petrol Sniffing relating to sale of premium unleaded at Mintabie. Council suggests APY adopt a bylaw restricting premium unleaded on the Lands. There are no police based at Mintabie and Council received reports of petrol being sold for \$70/bottle. The Inquiry has been re-opened and will be visiting Alice in October.

(g) Cross-border/tri-State policing is starting to work. Legislation has been passed in WA while NT and SA need to follow to enable conviction based on the law of the State where the crime was committed regardless of where apprehended.

4:30 Mr Singer leaves the meeting. Mr Huntington advises there is no quorum because of the departure of Mr Kenny earlier.

Mr Lewis leaves the meeting.

Mr Huntington arranges for Finlaysons to write to Fittock advising of the problem with quorum and request the return of Lewis.

Mr Lewis returns. Mr Singer returns.

4:50 pm meeting resumed with Mr Singer in the Chair.

Reports were provided on the Traditional Owner housing consultation meetings for the State governments \$25m housing offer conducted at Amata, Pukatja and Umuwa.

The Clearance Certificate for the Department of Families and Communities housing construction at Shirley Well was deferred until the next meeting when a map will be provided to assist discussion.

A report has been provided on the Indulkana Tree Site.

A resolution to raise the amount paid for Traditional Owner conducting cultural heritage surveys be raised to \$500/day was dealt with at the last meeting.

The Clearance Certificate for the AP Services-APY Quarry site near Fregon was deferred until next meeting when a map will be provided to enable discussion.

7. Roads Report

David Caspar provided a written summary included in the Minutes on the Report on Anangu Pitjantjatjara Yankunytjatjara Road Network for the Department for Transport, Energy and Infrastructure and Department of Aboriginal Affairs (generally referred to as the Mace Report). Mr Singer explained that there were schedules for maintenance attached to the report.
