#### 1. Welcome

Bernard Singer opened the meeting at 3:10 pm. The meeting was conducted in the General Manager's office using the conference phone and Telstra conference services. The conference was recorded and a CD called for.

## 2. Reason for Meeting

The Chairperson opened the meeting and asked the Legal Officer to explain why the meeting was called. The Legal Officer explained that Leonard Burton had called at Umuwa asking that the SGM be changed to the week commencing 19 May 2008 at the request of Joslene Mazel. The next day a letter from Acting Minister Gago arrived asking for an Executive Board meeting to appoint an Acting Chair. This was responded to advising that an Acting Chair was not needed and that the situation would be discussed at the SGM on 28 - 29 May 2008 and at the Executive Board meeting on 30 May 2008.

Burton then falsified the General Manager's letterhead to call an Executive Board meeting at Amata on 19 May 2008 which was switched to Alice Springs on Friday afternoon. An employee of AP Services was making the arrangements including accommodation. Burton told the Chairperson and Director that he could not change what he was doing without speaking to Joslene Mazel.

That Administration refer to appropriate agencies the notice issued by Leonard Burton for a meeting of the Executive Board at Amata today and the possible influence of Burton and funding of that proposed meeting by third parties to appropriate agencies.

### 3. Bungala CDEP and Indulkana

The Legal Officer explained that Bungala had written to APY enclosing a Police Statement of Larkin's alleging assault by the Chairperson in support of a request that he be dealt with under the Code of Conduct. The statement contained serious unproved allegations which were being defended. Otherwise there had been no response to APY's request for comment about whether Larkins destroyed the tree as reported by the APY Planning Officer.
